## Vendor Rules and Regulations

Application Deadline:	Applications must be postmarked no later than July 3rd, accompanied by this application, picture of booth, and space fee. For food booths, we will need a copy of health certification.
Check-in and Set-Up:	Vendors can begin sitting up their booths at noon on Friday, July 5 <sup>th</sup> . All vehicles must be removed from the park by 4:00PM on Friday. Booths must be open no later than 6:00 PM Friday and by 10:00 AM on Saturday.
Booth Size:	\$150.00 for a 10 X 10 or \$200.00 for a 10 X 20.
Items NOT allowed:	Including but not limited to water, soft drinks, throwing stars, martial art weapons, knives, brass knuckles, swords, drug paraphernalia, or any unlawful or lewd items. <b>VIOLATORS Will be shut down!</b>
Booth Services:	Electricity is <u>NOT</u> supplied All power needed to supply a booth must be supplied by the vendor operator and <u>not</u> the Fiesta.
Food/Craft Vendors:	Food vendors are limited to four food items. Please list items you intend on selling on the application. Craft vendors must list the types of arts and crafts you will sell.
Clean up:	You are responsible for your area. All booth construction and debris must be removed by each vendor.
Refunds:	There will be no refunds if a booth is cancelled after July 1 <sup>st</sup> 2019.
Notes:	Full payment is required with your application to reserve you space. (No payment agreements will be made) Each vendor is responsible for all sales tax, trash, signage, etc. Food Booths must have covers on their booths. No vendor booth will be allowed to sell any type of soft drink or water. <b>NO EXCEPTIONS.</b> Please enclose a photo of your booth with your application.
We do not anticipate turning any application down, but in the event there are an overwhelming number of applications or like food/refreshment items, we reserve the right to limit booth participation and location.
