The Permittee, and if the Permittee is a minor, then his or her undersigned parent/guardian hereby COVENANTS NOT TO FILE ANY ACTION AT LAW OR IN EQUITY against the club and its officers, agents, successors and assigns or any of them, in connection with any such claim the Permittee and, if the Permittee is a minor, which his or her parent/guardian may hereafter have against them or any of them; and the Permittee and if the Permittee is a minor his or her undersigned parent/guardian hereby AGREES TO INDEMNIFY AND SAVE HARMLESS the club and its officers, agents, successors and assigns, from any and all damages, expenses, reasonable attorney's fees and costs of court which they or any of them may suffer or incur, jointly or severally as a result of any such claim being made against them, or any of them, by the Permittee and, if the Permittee is a minor, by his or her parent/guardian or any other persons, associations or corporations whomsoever.
