\_\_\_\_\_ All vendors must set up in the designated space determined by the Vendor Director .

\_\_\_\_\_ Booth space provided by the Market staff is available on a first come, first serve basis and is not inclusive of the vendor fee. Vendors are responsible for their own provisions.

\_\_\_\_\_ Tents must be secured by weights, sand bags, or other suitable means and are the responsibility of the vendor.

\_\_\_\_\_ Vendors are required to remove all of their belongings, gear, trash, etc. prior to leaving the fiesta.

\_\_\_\_\_ Vendors agree to be honest about their products, growing practices or procedures.

\_\_\_\_\_ Vendors are to keep their space clean, safe, and hazard free at all times.

\_\_\_\_\_ Vendors selling Cottage Food Law products must provide the Fishin Fiesta Vendor director proof of a Food Handlers Certification.

\_\_\_\_\_ If I do not have one, I acknowledge that Freeport Host Club has made me aware that a Food Handlers Certification can be obtained at [www.learn2serve.com](http://www.learn2serve.com).

\_\_\_\_\_ Vendors preparing and selling food onsite (that does not meet Cottage Food Law Requirements) must have a valid Temporary Food Permit from the City of Freeport Health Department.

\_\_\_\_\_ Processed foods should have labels clearly stating the ingredients used.

\_\_\_\_\_ No firearms, drugs or lewd behavior will be allowed.
